Laboratory Supporting Services to Office Visits

Lab Processing Fee

This aids in the cost of equipment, time for processing, and drop-off/pick-up of specimen collections. Applicable to all primary care and specialty blood draw services, as external locations are also charging fee for service.

Interpretation Lab Fee

Applicable to Diagnostic Solutions Laboratory (GI-MAP), DUTCH, and Genova labs to aid in the clinical education and research performed prior to the office visit, which the return office visit is still subject to insurance coverage (towards a copay or deductible). Providers spend minimum 30 minutes (upwards to 90 minutes) to aid in the review, assessment, treatment curation, and discussion with any other provider prior to review with the individual.

Specialty Non-Covered Services Agreement
